**CORRIGENDUM**

It is hereby informed that, the Commission have issued Notification No.25/2018, dated 31-12-2018 for the posts fallen under Group-II Services in various departments. As per notification dated 31-12-2018, it was mentioned that 27 Post codes with 27 different departments were notified with a total of 110 C.F + 336 Fresh vacancies (both Executive and Non-executive posts).
