In compliance of the Orders of Hon’ble Supreme Court in C.A No. 7459/2009, dated.17/08/2017, Sri M. SRINIVAS a candidate for recruitment to the post of Junior Lecturer in Government Junior College in **Chemistry** subject with Regd.No.**40643722**, Vide Commission’s Notification No.04/2001 is hereby informed that he/she should attend for verification of the following Original Certificates at 09-00 A.M. on 20/12/2017 in the Office of the A.P.P.S.C., M.J.Road, Nampally, Hyderabad-500 001. Interview will be followed on the same day at 11-00 A.M.

➤ **He should produce the following certificates in Original and 2 sets of Photostat copies of the same for verification, failing which he / she will not be admitted to the Interview.**

<b>S.No</b>	<b>Original Certificates with a set of Photostat Copies of the same to be produced</b>
01.	<b>Date of Birth (SSC or its equivalent).</b> If age relaxation is claimed by the Retrenched Census Employee, A.P. State Govt. Employee, Ex-Service Man, N.C.C, Disabled (VH,HH & OH) candidates, BCs, SCs, STs. relevant certificates must be produced. <b><u>Candidature of Under aged / Over aged candidate would be rejected.</u></b>
02.	<b>PG Degree or B.A (Hons), B.Com (Hons), B.Sc (Hons) or its equivalent certificates</b> in Original and Memo of Marks in the relevant “ <b>SUBJECT</b> ” issued by the Competent Authority. Certificates from other than the Competent Authority are not valid. <b><u>P.G. Degree / Hon’s Degree acquired after 05/06/2001 would not be considered and candidature of candidate would be rejected.</u></b> <b>Important:</b> The candidates must have studied <b>Urdu as a Second Language at the Bachelor Degree Level for the Urdu Medium posts.</b>
03.	<b>Integrated Community Certificate</b> (issued by the concerned M.R.O / Tahasildar / R.D.O) by BC, SC & ST candidates. (Format prescribed in G.O.Ms.No.1973/Education, Dt.25.09.2010). <b>Important:</b> If Community Certificate is not submitted, his / her candidature will be treated as OC. In case he /she does not stand on OC Merit, he / she will not be allowed for interview.
04.	<b>Creamy Layer Certificate</b> in terms of orders in <b>G.O. Ms No.3, Backward Classes Welfare (C-2) Department, Dt.04/04/2006.</b> From Revenue Authorities to be produced by BC candidates as published in Para 1.13 of the Commission’s Notification No.19/2008 and Notification No.05/2008 candidates belonging to Backward Classes shall submit the certificate clarifying that he / she does not belong to the Section of Creamy Layer as per above mentioned G.O ( <b>BC candidates may download the format of Creamy Layer Certificate from the Commission’s website</b> ). If Creamy Layer Certificate is not submitted his / her candidature will be treated as OC. In case he/she does not stand on OC merit, he / she will not be allowed for interview. <b>Important: Certificate obtained in OBC format will not be accepted for claiming NCL status.</b>
05(a)	<b>School Study Certificate from IV to X class</b> by the candidate who has studied in school indicating the District and State. If Study Certificate is not submitted he / she will be treated as Non-Local. In case he / she does not stand on non local merit, his / her candidature to this recruitment will be cancelled and he / she will not be allowed for interview.

(b).	<b>In case of Private Study, Seven years Residence Certificate</b> in the state, prior to SSC issued by Tahsildar in the Prescribed Proforma. If Residence Certificate is not submitted he / she will be treated as Non-Local. In case he / she does not stand on non local merit, he / she will not be allowed for interview.
06.	<b>Physically Handicapped (VH, HH &amp; OH) Certificate in the Prescribed Proforma</b> prescribed in Notification No.04/2001, clearly showing the percentage of deformity issued by the District Medical Board / Civil Assistant Surgeon. If certificate is not submitted, his / her candidature will be treated as OC. In case he / she does not stand on OC merit, he / she will not be allowed for interview.
07.	<b>Declaration by the Un-employed</b> as prescribed in the Notification.
08.	In case there is any <b>spelling mistake / mistakes in the Certificates</b> produced by the applicant including the P.G. Degree Certificate, a Certificate from the Competent Authority stating that the Original Certificates pertain to him / her only are to be produced on the day of verification.
09.	<b>Copy of this memo</b> for verification of Original Certificates.
10.	<b>Check list:</b> Two copies of <b>Check Lists for Junior Lecturers in Government Junior Colleges</b> posts should be filled and signed by the candidate. The candidate should indicate his <b>Zonal preferences</b> with reference to <b>vacancy position hosted on the web-site</b> .
11.	<b>Attestation forms(two sets):</b> The candidate should also fill up all the required particulars in <b>both</b> the copies of <b>Revised Attestation Forms</b> and both the forms should be furnished at the time of verification of <b>documents duly attested by a Gazetted Officer or a Member of Central or State Legislature</b> . The Candidate is also directed to affix his / her <b>latest passport size photograph duly attested by a Gazetted Officer on the top of the each attestation form</b> .
12.	<b>Copy of Hall-Ticket</b> of the Written Examination.
13.	<b>6 latest passport size photos.</b>

- **IMPORTANT: No extension of time for production of the Original Certificates nor postponement of date of interview will be given for any reasons, whatsoever.**

**Other conditions/Instructions:**

01. The candidate must note that his admission to the Oral Test (Interview) is purely provisional subject to fulfilling the conditions regarding eligibility and other aspects with references to the Commission's Notification No.04/2001. On verification, if the conditions laid down in the Notification No. 04/2001 are not fulfilled or the certificates produced for verification are different to that of application, his / her candidature for interview to this recruitment will be rejected.

02. The candidate should be careful in providing the information regarding his eligibility and suitability for Junior Lecturers in Government Junior Colleges posts, and if knowingly any candidate furnishes incorrect information, provides false information or hides the facts then he is liable to be disqualified for the interview / selection and also be debarred from appearing for any of the recruitment examinations conducted by the Commission.
