

**ANDHRA PRADESH PUBLIC SERVICE COMMISSION:: HYDERABAD
RECRUITMENT TO THE POSTS OF ASSISTANT MOTOR VEHICLE INSPECTORS
NOTIFICATION NO.45/2008**

SELECTION NOTIFICATION

It is hereby notified that pursuant to Notification No. 45/2008 the selections (158) were made through selection notification dated 23/02/2012 subject to outcome of WPs 30167/2011 and batch, setting aside 16 vacancies to which the petitioners belong to.

The Commission had filed SLPs 22972-22985/2012 against the orders of Hon'ble High Court, dated 06/07/2012 in WPs 30167/2011 and batch. Based on Interim orders, dated 22/08/2012 in the SLPs, the selections for the 16 set aside vacancies were finalized subject to outcome of SLPs vide selection notification dated 24/08/2012.

The Hon'ble Apex Court, vide its orders dated 29/11/2016, upheld the orders of the High Court, according to which all the 17 petitioners in 14 WPs were considered for selection process and selections were finalized through selection notification dated 06/03/2017.

The Hon'ble High Court, vide its orders dated 25/01/2017 in W.P. No. 22101/2012, directed the Commission to consider the candidature of the Petitioner therein also along with others, in terms of the cut-off dates confirmed by the Supreme Court in SLPs. No. 22972-22985/2012 in relation to the 16 vacancies. In compliance of the orders as above, the selection process was carried out taking into consideration of all the candidates who possessed requisite qualifications as on 13/04/2009 in the ratio of 1:2.

Basing on the earlier merit list and supplemental merit list, the entire selections have been reviewed. Accordingly, the candidate, whose Register Number is given below has been provisionally selected for appointment to the post of Asst. Motor Vehicle Inspector, subject to the following conditions

- 1) That success in the examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as may be considered necessary having regard to his character and antecedents that the candidate is suitable in all respects for appointment to the service.
- 2) That the candidate is found physically fit for the post.
- 3) That the candidate should produce such other original certificates as may be required in accordance with the Rules.
- 4) That this provisional selection list and the appointment made is pursuant to the orders Dt. 25/01/2017 in W.P. No. 22101/2012 on the file of Hon'ble High Court of Andhra Pradesh.
