QUALIFYING EXAMINATION FOR ADMISSION INTO THE RASHTRIYA INDIAN MILITARY COLLEGE, DEHRADUN FOR THE TERM JULY-2019

Rashtriya Indian Military College has issued Notification for the Entrance Examination for admission into VIII Class in the R.I.M.C., Dehradun for the **Term July-2019**. The Written Examination will be held on **01/12/2018 (Saturday) and 02/12/2018 (Sunday) at Vijayawada**. The Viva Voce will be held on 04/04/2019. **Only Boys from Andhra Pradesh are eligible** for admission to the RIMC Examination.

Candidates appearing for the above test **should not be less than 11<sup>1/2</sup> years in age but should not have attained the age of 13 years as on 01/07/2019 i.e., they should have been born not earlier than 02/07/2006 and not later than 01/01/2008**. The candidate should either **be studying in Class VII or passed Class VII** from any recognized School at the time of admission to the RIMC i.e., **on 01/07/2019 exclusively from the state of Andhra Pradesh consisting of 13 Districts only**.

Road, Vijayawada, Andhra Pradesh-520 010 or the Rashtriya Indian Military College, Garhi Cantt, Dehradun, Uttarakhand, Pin-248003 on submitting Demand Drafft of **Rs. 600/-for General candidates and Rs.555/- for ST/SC candidates** along with Caste Certificate and enclosing self addressed (clearly Typed/Written in capital letters with pin code and contact number) cover size 40 x 30 cm duly affixing postal stamps worth of **Rs. 120/-** (Rupees One Twenty only).

RIMC / APPSC will not be responsible for any postal delay or loss in transit of prospectus caused by illegible or incomplete address.
