1. It is hereby notified that on the basis of the On-line Main Examination (CBT) held on 21/09/2020 FN & AN and 22/09/2020 FN for the posts of Assistant B.C Welfare Officer in A.P. B.C Welfare Service, Assistant Social Welfare Officer in A.P. Social Welfare Service and Assistant Tribal Welfare Officer in A.P. Tribal Welfare Service, vide Notification No.14/2019, Dated:21-02-2019, the candidates with the following Registered Numbers have been provisionally admitted for Oral Test (Interview), subject to verification of the eligibility as per the terms and conditions of Notification No.14/2019. The Oral Test will be held in the **O/o A.P.P.S.C., New HODs Building, 2nd Floor, M.G. Road, Opp. Indira Gandhi Municipal stadium, Vijayawada, Andhra Pradesh-520010**. The date of interview and candidate wise schedule of Oral Test (Interview) will be placed in the Commission's website separately. Individual call letters will be sent to candidates shortly. 2. The candidates who are provisionally qualified for Oral Test (Interview) are required to produce the following Original Certificates for verification of eligibility to admit for Oral Test on the day of Oral Test.

- i) **Age,**
- ii) **Proof of age relaxation,**
- iii) **Qualifications,**
- iv) **Study Certificates,**
- v) **Integrated Community Certificate in case of reserved candidates.**
- vi) **Non-creamy layer certificate in case of B.Cs from Revenue Authorities (As per G.O. Ms. No.3, Backward Classes Welfare (C-2) Department, Dt:04-04-2006 and G.O.Ms.No.26, BC Welfare (C) Dept., Dt:09-12-2013) who claim reservation under BC Community.**
- vii) **Local Status certificate who migrated from Telangana to Andhra Pradesh.**
- viii) **P.H. certificate in case of disabled candidates.**

In case of failure to produce any of the certificates of eligibility as claimed by the candidate in the online application, the candidature is liable for rejection. The Commission has the right to disqualify any candidate, if he/she is not found eligible for any reason. 3. The candidates shortlisted under Disabled quota shall be subjected to Medical Examination at respective Medical Board at Visakhapatnam. The date of medical examination will be intimated at the time of verification of certificates.
