2. Interested parties may submit their highest quotations in the enclosed pro-forma (Annexure-II). The quotation in sealed cover, superscribed as "**QUOTATION FOR PURCHASE OF CONDEMNED VEHICLES**" should be addressed to the Secretary, APPSC, 2nd floor, New HODs building, M.J Road, Vijayawada and may be dropped in the tender box kept in Room No.213 **latest by 29/01/2019 at 4:00 PM**. The quotations will be opened on the same day at **4:00 PM**. The bidders, who wish to be present at the time of opening, may do so.

3. The vehicles will be available for inspection between **10:00 AM to 4:00 PM** in the previous office of APPSC, Nampally, M.J.Raod, Hyderabad.

4. The sale will be governed by the following terms and conditions:-

- (i) The sale will be conducted on "Tender cum Negotiations basis".
- (ii) The bidder is required to pay an earnest money of Rs. 10,000/- in the form of Demand Draft in favor of "**The Secretary, APPSC, Vijayawada**" along with the quotation. The quotations received without earnest money will not be considered as valid and shall not be accepted. (ANNEXURE-I)
- (iii) The bids received after the stipulated date and time i.e. **4:00 PM on 29/01/2019** will not be accepted. The bids received through e-mail/FAX/telegram will not be considered. However, bids through speed-post/registered post will be considered only if received before the stipulated date and time.
- (iv) The bids with overwriting/cuttings in the quoted rates will not be considered.
- (v) The bidders will not be allowed to withdraw their bids, failing which their earnest money will be forfeited.

- (vi) The successful bidder will be required to deposit the entire bid money by means of direct Cash payment to the concern officials within three working days of the acceptance of the bid. The earnest money of the successful bidder will be released only after he deposits the sale proceeds. The earnest money will be forfeited in case he backs out for whatever reason.
- (vii) The earnest money of unsuccessful bidders will be returned without interest.
- (viii) The sold vehicle has to be removed by the successful bidder from Prathibha Bhawan, Nampally, M.J.Road, Vijayawada within 24 hours of depositing the sale proceeds and at their own expenses.
- (ix) The vehicle will be disposed off on "*As and where it is*" basis and no guarantee for its worthiness or quality will be given by this Department.
- (x) As per the directions of the State Transport Authority, Govt. of A.P, the transfer of ownership of auctioned/condemned vehicle cannot be considered. However, a "*No Objection Certificate*" may be obtained from the Registering Authority for such vehicles for re-registration elsewhere outside the A.P region. The formalities have to be completed by the successful bidder at his own cost expeditiously. The Department will not be responsible for any lapse on his part in this regard.
- (xi) The undersigned reserves the right to accept or reject any/all of the quotations or cancel the tender at any time without assigning any reason.
