The Andhra Pradesh Public Service Commission (APPSC), Vijayawada, invites scaled bids from reputed firms/suppliers for supply of LED TVs.

1. Bids in sealed envelopes, on prescribed tender documents should reach to the Procurement Department, APPSC VIJAYAWADA before 4:00 pm on **30 December 2019** and write our inquiry No. 536/Admin I/2019 on the top of the envelope. Open bids will not be accepted.
2. Tenders will be opened by the concern Committee in the presence of bidders at 5.00 pm on **31 December 2019** in the Conference Hall Room No. 234, APPSC, Vijayawada.
3. Please quote unit price for item inclusive of all taxes, transportation, loading/unloading and fixing/installation and commissioning, testing and handing over.
4. Bids should remain valid for two weeks from the date of submission.
5. You are required to enclose **EMD for Rs.10, 000/-** (Rupees ten thousand only, refundable) through Demand Draft payable to the Secretary, APPSC, Vijayawada with your bids document.
6. The bids received after last date and time of submission will not be considered.
7. The Secretary, APPSC, reserves the right to reject all or any tender wholly or partly without assigning any reason whatsoever.
8. Bidder shall continue to provide maintenance and support during the warranty period (minimum two years).
9. The Technical Bid, Financial Bid and EMD are to be submitted in three envelopes duly sealed super-scribed on the top as **Tender No. 536/Admn-1/2019**.
10. All pages of bid including terms and conditions of tender document should be signed with stamp by authorized person of bidder only and serially numbered.
11. Both the bids should be submitted on the same day and time as explained above.
12. Bidders are advised to submit the Bids strictly based on the terms and conditions and specification contained in the tender document and not to stipulate any deviations. Conditional bids are liable to be rejected.
13. The Secretary, APPSC reserves the right to split the job into two or more parts and to award the work to separate agencies/bidders subject to the work experience and fulfillment of other terms & conditions and specifications.

14. The technical specifications of the items proposed to be purchased are given in **Annexure I**.
15. **Financial Bid** should be given in the proforma attached as **Annexure-II**.
16. Agency while submitting its bids, should keep following points in view:
 - 16.1. Rates should be quoted only for one of the brands/make as specified in **Annexure I**.
 - 16.2. Unless specified in technical details, quotation for optional items should not be the part of proposal.
 - 16.3. Agency should quote only for products of the brand/make with specifications as given in **Annexure I**. Quotation for alternate products should not be given.

17. Acceptance / Rejection of Bid:

- i. The Commission does not bind itself to accept the lowest tender.
 - ii. The Commission also reserves the right to accept or reject any tender in part or full without assigning any reason whatsoever.
 - iii. The Commission also reserves the absolute right to reject any or all the Bids at any time solely based on the past unsatisfactory performance by the bidder(s). Opinion/decision of the Commission regarding the same shall be final and conclusive.
 - iv. Bidder must have GST Number and vendor number.
18. No corrections or overwriting will be entertained in Bill of Quantities by using correcting fluid.
19. The rates quoted by bidder shall remain firm till completion of all works even during the extended period, if any, on any account what so ever. It is provided that the bidder shall not change any of the rates quoted in the tender till the completion of work.
20. Violates any of the terms and conditions stipulated in the agreement:
 - i) Payment will be made on successful completion of the job by the selected bidder to the Satisfaction of the Commission.
 - ii) The successful completion of the job mean that the entire job has been completed to the satisfaction of the Commission and repair/ maintenance/ changes/modifications, if any, have been carried out by the selected bidder.
 - iii) All statutory deductions as applicable shall be made from the due payment of the bidder.

- iv) The payment shall be released on successful completion of supply and installation to the satisfaction of the Commission against the bill provided by the party after making necessary statutory deductions as applicable. No interest has to be paid in case of any delay in the payment.
21. In case of any dispute, the decision of the Secretary, APPSC will be final and binding on you.
22. Bidder is required to attach the Declaration Certificate.
